STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Document

The organisation is a charitable company limited by guarantee, incorporated on 15 October 1993 and registered as a charity on 15 October 1993. The company was established under a Memorandum of Association that established the objects and powers of the charitable company and is governed under its Articles of Association. In the event of the company being wound up, members are required to contribute an amount not exceeding £1.00.

The Federation registered with the Charities Commission Northern Ireland on 12 September 2014.

Recruitment and Appointment of Management Committee

The directors of the company are also charity trustees for the purposes of charity law and under the company's Articles are known as members of the Executive Committee. Under the requirements of the Memorandum and Articles of Association the members of the Executive Committee are elected to serve for a period of one year after which they must be re-elected at the next Annual General Meeting.

Nominations are sought from the Federation's membership on an annual basis. Nominations are sought for Executive Committee members and for four Officer roles- chairman, vice-chairman, treasurer and secretary. Where more nominations are received than there are vacancies for Executive Committee Members elections are held at the AGM.

The members at the AGM elect the Officers of the Federation. No person may hold the office of Chairman for more than two consecutive years.

Committees are appointed annually to progress business more effectively. These currently are the –

- Management Committee;
- Programme Committee;
- Publications and Communications Committee; and the
- Joint FULS/Federation of Local History Liaison Committee

Trustee Induction and Training

Whilst no formal training is given by the Federation, trustees are encouraged to attend relevant training courses offered by different organisations in Northern Ireland, as they arise from time to time. New trustees are provided with a Welcome Pack containing, inter alia, copies of the Federations Memorandum and Articles of Association, corporate governance rules and operational guidance. Additional guidance material published by Companies House and Charities Commission NI is made available for information. These rules and notes are available on the Federation's on-line Archive and Resource. The trustees also bring to the organisation relevant skills and training gained through their occupations and other activities.

Organisational Structure

The Federation for Ulster Local Studies has an executive committee of 11 members, plus up to five co-opted members who meet regularly throughout the year and are responsible for the strategic direction, policy and operation of the charity. Note: There are two secretaries- the Secretary and the Company Secretary. The Secretary, as an officer elected at the AGM, has voting rights. The Company Secretary is appointed by the Executive Committee and may be a member of that Committee. If not a member of the Executive Committee, the Company Secretary does not attend committee meetings and does not have voting rights.

OBJECTIVES AND ACTIVITIES

The company's objectives and principal activities are to link historical societies in the nine counties of Ulster to promote the study and recording of the history, antiquities and folk life of Ulster. The main objectives and activities for the year focuses on the development of member services and improved communication with and between member societies and with co-operation among voluntary associations concerned with local historical studies in Ulster and between these associations and relevant organisations, statutory and voluntary. The strategies employed to assist the Federation to meet these objectives included the following:

- To provide direction through organising and executing educational workshops and seminars so that both local societies and the general public can develop the skills and methodologies to enable them to further their own studies;
- To encourage the publication of accessible and stimulating material that encourages widespread participation in local studies and to provide opportunities for people to meet, network and exchange ideas and experiences;
- To develop member societies presence on the internet and develop and maintain electronic communications with and between them;
- To plan for targeted training groups who wish to use local studies in their own field.

Strategy and Planning

The Strategic Plan debated and adopted by the Annual General Meeting on 28 November 2009 governs the Federation's activities. The Plan was reviewed and updated during the current year.

The Executive Committee's governance arrangements are set out in the following measures

- Rules for the Conduct of Officer and Executive Committee Nomination and elections at AGM
- A Code of Financial Practice

ACHIEVEMENTS AND PERFORMANCE

The main areas of charitable activity are the provision of educational workshops and seminars; annual journal and regular information bulletins, educational trips, co-operation with organisations in similar and related fields, providing additional membership services including public liability insurance.

Memberships Services

During the year-

- Four newsletters were issued, with news of planned events and enhanced services;
- a Seminar was held in Mossley Mill, Newtownabbey on 9 June 2018. The Seminar dealt with the origins, history and development of the Suffragist and Suffragette movement and its continuing impact today. It also reviewed the Centenary of Anniversaries programme and discussed how societies could get involved. It also provided societies with help in planning and developing projects, preparing publications and with the variety of funding sources available;
- The 2019 Spring Seminar in the Cardinal O'Fiaich Library had three major presentations; the Armagh Rail Disaster of 1889; the 1918 General Election and its impact on Ulster; and the impact in Ulster of the Spanish Flu Epidemic of 1918/19. Executive Committee members gave short talks on how to make best use of societies' websites and Facebook, on the 'Perfect Society' and on the use of on-line resources.
- The Executive Committee reviewed its Strategic and Action Plans at an away-day in Mossley Mill, Newtownabbey on 19th January 2019. The revised approach will form the basis for future action.
- the Federation's list of available speakers was revised and updated to over 150 speakers and nearly 600 topics;
- a new edition of the Federation's annual journal, *Due North*, was launched at the AGM on 17 November 2018. Six hundred copies were printed;
- the Federation's Exhibition and Programme to publicise and promote the joint FULS/FLHS joint *Hidden Gems and Forgotten People* project and website, launched in September 2016 continued throughout the period. The programme is supported by Libraries NI. In the current period an exhibition was held in Carrickfergus Museum from 10th to 19th December 2018
- the Federation's website continued to provide additional information about members' programmes and events of general interest and its news section carried 18 updates of information;
- The Society websites provided by the Federation were updated as required;
- At year end membership stood at 95 Societies and 16 Individual members.

Working with others

The Management committee continued to develop working relationships with other groups-

- Public Records Office NI; encouraging individuals and communities to develop their interests in local studies;
- Libraries NI, society meetings, Hidden Gems and Forgotten People exhibitions;
- Community Relations Council, funding individual projects;

- Carrickfergus Museum in hosting a Hidden Gems & Forgotten People Exhibition;
- Ulster Local History Trust in disseminating information on events;
- Federation of Local History Societies in co-operating in joint events and programmes. A joint Committee meets regularly, alternating between jurisdictions. Activities include joint membership trips in Ireland, alternating annually; historically orientated trips to Great Britain and continental Europe, joint seminars and workshops covering the whole of the island of Ireland; joint projects e.g. a joint website on Hidden Gems and Forgotten People.

Public Liability Insurance

The Federation offers public liability insurance as a service to its member societies. The insurance covers attendance of society members and visitors at Society events including field trips and visits to other Societies, anywhere in the European Union. The scheme applies only to Societies based in Northern Ireland, although visitors to members' meetings and events from any jurisdiction are covered.

FINANCIAL REVIEW

Principal Funding Sources

Income is generated from membership fees, insurance contributions, sales of *Due North* and legacy publications on CD, and from event fees.

Investment Policy

Aside from retaining a prudent amount in the reserves each year most of the Charity's funds are to be spent in the short term so there are few funds for long term investment.

Reserves Policy

The Executive Committee, in the light of changes to the organisation's structure, has reviewed the options in respect of the reserves. It was decided to review the options for longer term investments and the position will be clarified in the next financial year.

PLANS FOR FUTURE PERIODS

The Federation plans to continue its current activities in line with available resources. This involves consultation with members and seeking support from other like-minded bodies in fulfilling heritage projects. Funding will be sought for the delivery of specific projects and resources will be shared, if possible, with other organisations to ensure viability is maintained.

INDEPENDENT EXAMINER

Mrs Roisin Shanks (ACA) has been re-appointed as independent examiner for the ensuing year. At the 2018 AGM, Mrs Shanks agreed to be reappointed for the 2019-2019 year.

BASIS OF INDEPENDENT EXAMINER'S REPORT


