#### SECRETARY'S REPORT

#### Introduction

This report covers the year from 1<sup>st</sup> April 2021 to 31<sup>st</sup> March 2022. The impact of the Covid-19 pandemic continued to severely restrict the activities of Member Societies during the period being reported and in many cases seen the complete cessation of business. This report sets out the very limited activities of the Executive Committee since 1st April 2021. Because of the impact of the Covid-19 pandemic, all meetings were via ZOOM.

## Membership

Society Membership stands at 92, Individual Membership, 23. Many societies were inactive during the year and two societies ceased operations. Twelve societies had not renewed their membership for the year despite several reminders but all have been invited to re-join for the incoming year and current indications are that society activity is on the increase with many societies now up and running again.

In view of the continuing impact of the pandemic on Members' activities, and their financial resources, as well as the fact that the Federation is at present able to provide only limited services, the Executive Committee decided to continue the reduction of membership fees by 50% for the 2021-2022 year. Members (Society and individual) that paid by Standing Order were refunded the difference in November 2021.

The committee are suggesting that all major dates are regularised and end on 31<sup>st</sup> March i.e. financial year, insurance year and membership year (currently 30<sup>th</sup> September). A motion will be put to the annual general meeting to facilitate this with effect from 1<sup>st</sup> April 2023.
